6.02 <u>Number of Directors</u>

- (a) The Board of Directors of the Association shall consist of not fewer than 2 and not more than 11 Member directors. Of those the immediate past president of the Association shall be acclaimed as a director and the remainder shall be elected by the Association at its Annual General Meeting. Other than as provided in Clauses 6.02 (b), 6.02 (c), 6.02 (d), 6.02 (e), and 6.02 (f) hereof, each director shall be elected for a term of 2 years each provided however that no director shall hold office for more than 3 consecutive terms.
- 7.02 <u>Duties of Executive Officers</u>(f) There are currently no duties listed for the past-president
- 7.04 Executive Committee

(a) The Executive Committee shall consist of the officers of the Association and the immediate past president of the Board

6.02 Number of Directors

The board has been working hard to continue bringing our programming back to pre-COVID levels as well as to enhance and expand our existing program opportunities.

Our bi-annual casino funding is a major portion of our yearly budget and is critical to the success of our association and programs!

The ABA continues to be an active member of the Alberta Music Advocacy Alliance, whose mandate is to advocate for music education in this province. Please check out their website at http://www.albertamusicadvocacy.ca.

Our Provincial Honour Bands continue to show a strong return post-COVID. The Alberta Wind Symphony and the Alberta Junior Honour Band both participated in a weekend residency on March 3-5 at Red Deer Polytechnic, culminating in an afternoon concert in the Performing Arts Centre in which the two ensembles shared the stage and performed to a sold-out crowd. Dr. Darren Oehlerking from Saskatoon led the Wind Symphony and Verna Ahner from Calgary led the Junior Honour Band. Both did an amazing job creating a truly memorable experience for every member of each ensemble.

Festival of Bands continues to rebound strongly post-Covid, with this year's festival hosting close to 130 different ensembles from across Canada over a seven-day festival. Our festival offers an excellent opportunity for students to showcase their hard work and talent and receive first class adjudication and clinics with both local and national clinicians. Congratulations to our Superior Band Award winners and Adjudicators' Choice Award recipients! We look forward to seeing many of you again in 2024.

Music Conference Alberta 2022 was a resounding success, hosted by MacEwan University here in Edmonton. It was a joy to see the personal interactions between colleagues as we returned to an in-person conference! Truly, the strength of Conference and of our Association is in the professional and personal connections that we make and maintain as colleagues and friends. The challenges of our music making career are many, but the support we receive from each other is invaluable. Thank you to our MCA joint

organizing committee for putting together the conference and for centering voices that have often been pushed to the sidelines. We continue to strive for diversity and inclusion in our Association and to support it in your home programs.

This meeting we are saying farewell and thank you to departing board member, Ellie Neufeld. Ellie has stepped away from the board to accept a teaching position in Georgia where she also did graduate work in conducting. Although Ellie was only with the board a short time, she worked tirelessly on a number of program committees and was a great source of new ideas. She will be missed, but we wish her all the best in her new position!

Don Closson

At the Print Music Dealers Conference in San Diego Don was awarded the "Norm Award" for exemplary contributions and ingenuity. The Alberta Band Association bestowed Don with the "Award of Distinction" for exceptional service and dedication. His company Music Direct was selected for the Canadian Business Review Board Best Businesses in Canada in 2021. He volunteers on a number of committees and boards. He strives to play saxophone early every morning, enjoys time on guitar and bass, and encourages his three boys in their musical pursuits.

Vanessa Pastor

Vanessa's immense passion for instrumental band was conceived when she was handed a flute in grade 5, and grew stronger when she was introduced to marching band in grade 9. Vanessa joined the Red Deer Royals in 2011 as a flute player, and became a drum major in 2014. He is currently the Fine Arts department head at McNally High School in Edmonton, teaching band, choir, jazz band and contemporary music. As an educator and composer, Peter brings a vibrant love of music to his students, encouraging them towards excellence in performing and creating music. He is passionate about helping students discover beauty, expression, and community through music and developing their own musical voice through performance, improvisation, and composition. Peter's musical journey began with piano lessons at age 6 and continued in highly recognized band programs at Westminster Jr. High (1989-1992) and Ross Sheppard High School (1992-1995) in Edmonton. He found his deep passion in music when he discovered the art of jazz piano in Grade 9 and later enrolled in the Grant MacEwan jazz program where he studied with Charles Austin, completing diplomas in
